Dear Speaker Ryan, Leader McConnell, Leader Schumer, and Leader Pelosi:

With less than a month before Members of Congress will go home for the holidays, we urge you to pass legislation to enable Dreamers who are currently living, working, and contributing to our communities to continue doing so.

As companies and associations whose industries span the diverse breadth of our economy - including some that recently came to Washington with our Dreamer employees to speak to our elected representatives - we recognize firsthand their important contributions to our companies and our country. DACA recipients contribute billions of dollars to the GDP; they pay federal, state, and local taxes; they work at our companies, teach our children in school, and serve in our military. We were encouraged to see nearly 20 Republican House members join together recently to call for passage of legislation to protect Dreamers. Deporting hardworking young individuals would cost the U.S. economy hundreds of billions of dollars in lost GDP and \$24.6 billion in Social Security and Medicare tax contributions. An overwhelming majority of Americans of all political stripes - upward of 90% - agree that we should protect Dreamers from deportation.

Congress has the opportunity to show leadership in passing a permanent legislative solution and allowing Dreamers to continue to work toward the American dream. We urge you to pass legislation without further delay.
